## • Financial records, money laundering and insider trading

All business transactions are carried out transparently and recorded. There is no actual or attempted involvement in money laundering or terrorist financing.

### • Gifts, hospitality and entertainment

Any entertainment or hospitality business is kept reasonable in nature, entirely for the purpose of maintaining good business relationships and not with the intention of influencing Merquimia Internacional's decisions about future business.

#### Conflict of interests

Any and all conflicts of interest in any commercial transaction which of Merquimia Internacional is aware will be declared to allow the opportunity to take appropriate action. Whenever possible, employees should avoid Conflicts of Interest. If a Conflict of Interest has occurred or if an employee is faced with a situation that may involve or give rise to a Conflict of Interest, the employee must notify his or her immediate superior in order to resolve the situation in a fair and transparent manner.

# 2. Work is carried out on the basis of freely agreed and documented conditions of employment

Our policies are adopted and enforced, respect employees, permanent and casual, and, at a minimum, protect their rights under the employment contract, local and national labor and social security laws.

### 3. The work is carried out voluntarily

At Merquimia Internacional, forced and compulsory labor or in conditions of slavery (reduction to servitude) is not acceptable. Workers are free to work or not to work or to join or not to join a union or to remain in it or leave it. They have freedom of association and the right to collective bargaining.

# 4. All workers are treated equally with respect and dignity

There is no discrimination in hiring, providing, compensating. training, terminating or retiring based on race, national origin, religion, age, sex, status, sexual orientation, union or political membership, a disability or pregnancy. No worker is subject to any form of physical, sexual, psychological or verbal harassment or abuse, or any other form of intimidation. Special attention is paid to the rights of workers most vulnerable to discrimination. Merquimia Internacional aims to prevent, care for, raise awareness and quide workplace workers in matters of harassment, sexual harassment at work, violence and discrimination against women and people with diverse sexual orientations in order to have decent work environments. based on respect for human rights and the achievement of equality.
